

ORDINANCE NO. 77B

AN ORDINANCE OF THE TOWN OF STRATTON, KIT CARSON COUNTY, COLORADO, TO ADOPT A MEMORANDUM OF UNDERSTANDING WITH STRATTON AREA FOUNDATION 2, INC., A COLORADO NON-PROFIT CORPORATION

WHEREAS, the Town of Stratton, hereinafter referred to as the "Town," is a statutory town as defined by Colorado Revised Statutes, Title 31; and

WHEREAS, Colorado Revised Statutes, 31-15-101(1)(C) gives authority to the governing bodies of municipalities to enter into contracts, provided that such contract is in the best interests of the citizens of the Town; and

WHEREAS, the Board of Trustees of the Town, hereinafter referred to as the "Board," has determined that it is in the best interests of the citizens of the Town to enter into a Memorandum of Understanding, hereinafter referred to as "MOU", with the Stratton Area Foundation 2, Inc., a Colorado non-profit corporation, hereinafter referred to as the "Foundation", for the purpose of partnering and operating a child care center in the Town; and

WHEREAS, both the Town and the Foundation recognize a mutually vested interest in providing child care services within the Town to foster the economic health of the Town and surrounding community; and

WHEREAS, the parties agree that the location of the child care center shall be upon real property owned by the Foundation and located at 425 Colorado Avenue, Stratton, Colorado;

NOW THEREFORE, BE IT RESOLVED AND ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, KIT CARSON COUNTY, COLORADO:

1. Upon approval of the proposed MOU by the Mayor and the Board, the Mayor and Town Clerk are authorized to sign the MOU which will set forth the details and understanding of both the Town and the Foundation concerning the operation and administration of the proposed child care center.

2. Any details or needed provisions which are not currently set forth in the MOU shall be negotiated by the parties in accordance with the MOU.


