

ORDINANCE NO. 82A

AN ORDINANCE PERTAINING TO THE SEWER DEPARTMENT OF THE TOWN OF STRATTON, COLORADO, AMENDING ORDINANCE 51A, OF THE ORDINANCES OF THE TOWN OF STRATTON, COLORADO.

WHEREAS, the Board of trustees of the Town of Stratton, Colorado, finds that because of increased costs of labor, and materials and other inflationary pressures, and because the Town of Stratton will be required to make substantial improvements to its sewer system, it is necessary to increase consumer rates for sewer services.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO:

Section 1. Section 5. of Ordinance 51A, of the Town of Stratton is hereby amended to read as follows:

SECTION 5. Sewer Service Charges.

A. Residential users within the corporate limits of the Town of Stratton shall pay a monthly sum of six dollars and fifty cents (\$6.50) per service. Users outside the corporate limits of the Town of Stratton shall pay a monthly sum of seven dollars and fifty cents (\$7.50) per service.

B. Commercial users within the corporate limits of the Town of Stratton shall pay a monthly sum of seven dollars and fifty cents (\$7.50) per service. Users outside the corporate limits of the Town of Stratton shall pay a monthly sum of ten dollars (\$10.00) per service

Section 2. It is hereby declared that an emergency exists and that this Ordinance is necessary for the immediate preservation of the public health, peace, welfare and safety of the residents of the Town of Stratton, Colorado, and shall be in full force and effect after its passage and publication as provided for by law.

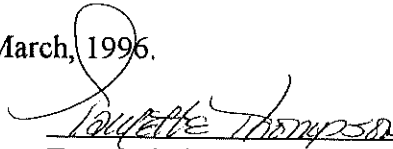

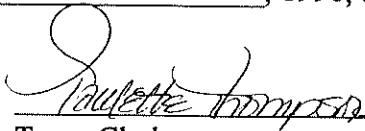
