

ORDINANCE AUTHORIZING THE MAYOR TO SIGN AN INTERGOVERNMENTAL AGREEMENT CREATING THE KIT CARSON COUNTY EMERGENCY TELEPHONE SERVICE AUTHORITY IN ORDER TO ESTABLISH AND OPERATE AN EMERGENCY TELEPHONE SERVICE AUTHORITY WITHIN KIT CARSON COUNTY INCLUDING KIT CARSON COUNTY, THE CITY OF BURLINGTON, TOWN OF BETHUNE, TOWN OF STRATTON, TOWN OF SEIBERT, AND TOWN OF FLAGLER, TOWN OF VONA, THE BURLINGTON FIRE DISTRICT, STRATTON FIRE DISTRICT, SEIBERT FIRE DISTRICT, FLAGLER FIRE DISTRICT, VONA FIRE DISTRICT, AND THE COMMUNITY AMBULANCE SERVICE, AUTHORIZING THE IMPOSITION OF AN EMERGENCY TELEPHONE CHARGE UPON TELEPHONE EXCHANGE ACCESS FACILITIES WITHIN ALL OF THE AFOREMENTIONED AREAS; AND AUTHORIZING SERVICES SUPPLIERS TO COLLECT SAID EMERGENCY TELEPHONE CHARGES.

WHEREAS, in the interest of protecting and preserving public safety and welfare, it is desirable that all citizens within Kit Carson County, Colorado be provided with emergency telephone service (hereinafter called "E9-1-1") to aid the timely provision of emergency services; and

WHEREAS, the Emergency Telephone Service Act, Colo. Rev. Stat. 29-11-101, *et. seq.* (hereinafter called the "Act") authorized governing bodies to impose a charge upon each exchange access facility (telephone service subscriber line) to pay for the installation costs and the directly related costs of the continued operation of an emergency telephone service ("E9-1-1"),

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Stratton, Colorado, that the Mayor is authorized to sign the Intergovernmental Agreement creating the Kit Carson Emergency Telephone Service Authority, (hereinafter called "Authority").

BE IT FURTHER ORDAINED that pursuant to Colo. Rev. Stat. 29-11-101, *et. seq.* upon all telephone access facilities within said County, the telephone service suppliers are hereby authorized to collect the emergency telephone charge in a monthly amount not to exceed seventy cents (\$.70). Upon recommendation of the Authority, the Board of County Commissioners may, by ordinance, raise or lower the emergency telephone charge, but in no event, shall such charge exceed \$.70.

BE IT FURTHER ORDAINED that the corresponding Intergovernmental Agreement is approved, that the Mayor is authorized to execute it on behalf of the Board of Trustees

of the Town of Stratton, State of Colorado, and that the Town of Stratton, and its officers, agents and employees are authorized to perform under it on behalf of the Town of Stratton according to its terms.

BE IT FURTHER ORDAINED that this Ordinance shall not be effective until the Intergovernmental Agreement creating the Kit Carson County Emergency Telephone Service Authority and concerning the implementation of an emergency telephone service system is signed by representatives of all parties thereto.


