A RESOLUTION AUTHORIZING AND DIRECTING THE TOWN CLERK TO PUBLISH NOTICE OF CANCELLATION OF THE REGULAR TOWN ELECTION ON APRIL 5, 2022, AND DECLARING THE ELECTION OF CANDIDATES

WHEREAS, § 31-10-507, C.R.S authorizes a municipality that has in an ordinance adopted a requirement for an affidavit of intent for write-in candidates, also provided that, if the only matter before the voters is the election of persons to office and if, at the close of business on the sixty-fourth day before the election, there are not more candidates than offices to be filled at such election, including candidates filing notices of intent, the town clerk may be authorized to cancel an election in such an event; and

WHEREAS, on January 23, 2020, the Board of Trustees adopted Ordinance 66-B, which provides for write-in candidates for elections and the cancellation of elections if there are not more candidates than offices to be filled at such election, pursuant to § 31-10-507, C.R.S and;

WHEREAS, as of the close of business on the 64th day before the Town election scheduled for April 5, 2022 for purposes of filling five vacancies on the Board of Trustees and the one Mayor vacancy, there were not more candidates than offices to be filled, including candidates filing an affidavit of intent; and

WHEREAS, the only duly qualified candidates for a vacancy of the Board of Trustees on the 64th day before the election are: Sonia Huppert, 541 Wyoming Avenue, Stratton, CO; Matthew Brachtenbach, 714 Nebraska Avenue, Stratton, CO; Casey Pace, 73 Main Street, Stratton, Colorado; and Jeffery Shean, 221 Third Street, Stratton, CO; and

WHEREAS, the only duly qualified candidate for a vacancy for Mayor on the 64th day before the election is: Sonya Pace, 311 Main Street, Stratton, CO; and

WHEREAS, there are no ballot issues to be decided at the April 5, 2022 election.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO THAT:

Section 1. Cancellation of Election. The Town Clerk is hereby authorized and directed to cancel the regular Town election scheduled for April 5, 2022, there being a lessor number of candidates and vacancies and there being no ballot issues to be decided at said election.

Section 2. Candidates for Office Declared Elected. The Town Clerk is hereby authorized and directed to post and publish a notice of cancellation of election, immediately and declare elected to the Board of Trustees the following persons: Sonia Huppert, 541 Wyoming Avenue, Stratton, CO; Matthew Brachtenbach, 714 Nebraska Avenue, Stratton, CO; Casey Pace, 73 Main Street, Stratton, Colorado; and Jeffery Shean, 221 Third Street, Stratton, CO; and declare elected to the position of Mayor the following person: Sonya Pace, 311 Main Street, Stratton, CO; and

Section 3. Posting of Notice of Cancellation. Notice of cancellation of Election, and or a copy of this Resolution, shall be posted at each polling place and in not less than one (1) other public place.

Section 4. Immediate Effect. This Resolution shall take effect immediately upon adoption.
